From this review, it is our considered opinion that a settlement in the amount of **THIRTY THOUSAND DOLLARS AND ^{NO}/Cents (\$30,000.00)** is in the best interest of the City of Detroit.

We, therefore, request authorization to settle this matter in the amount of **THIRTY THOUSAND DOLLARS AND ^{NO}/Cents (\$30,000.00)** and that Your Honorable Body direct the Finance Director to issue three (3) drafts in the following manner:
