

## RESOLUTION

**COUNCILMEMBER: Fred Durhal III**

**WHEREAS**, Sections 9-507 and 33-1-62 of the 2012 Detroit City Charter permits the Director of the General Services Department (“GSD”) on behalf of Detroit Parks & Recreation (“DPR”) to amend a Fee Schedule subject to the approval of City Council, and;

**WHEREAS**, the Detroit City Council previously approved an Updated Fee Schedule within the GSD budget approved on April 8, 2025 and;

**WHEREAS**, the GSD Director has reviewed and prepared an Amendment to the DPR Fee Schedule to include two new facilities and updates to two existing facilities, boxing training and equipment rentals, and;

**WHEREAS**, the City Council has reviewed the proposed Amendment to Fee Schedule for DPR facility, equipment rental and boxing training;

**RESOLVED**, The Detroit City Council approves the Amended Fee Schedule for the Detroit Parks & Recreation facility, equipment rentals and boxing training which shall become effective immediately upon the approval of your Honorable Council.
