BE IT FURTHER RESOLVED, that this approval of the banner installation by The Parade Company be contingent upon the approval of this resolution by the Honorable City Council.

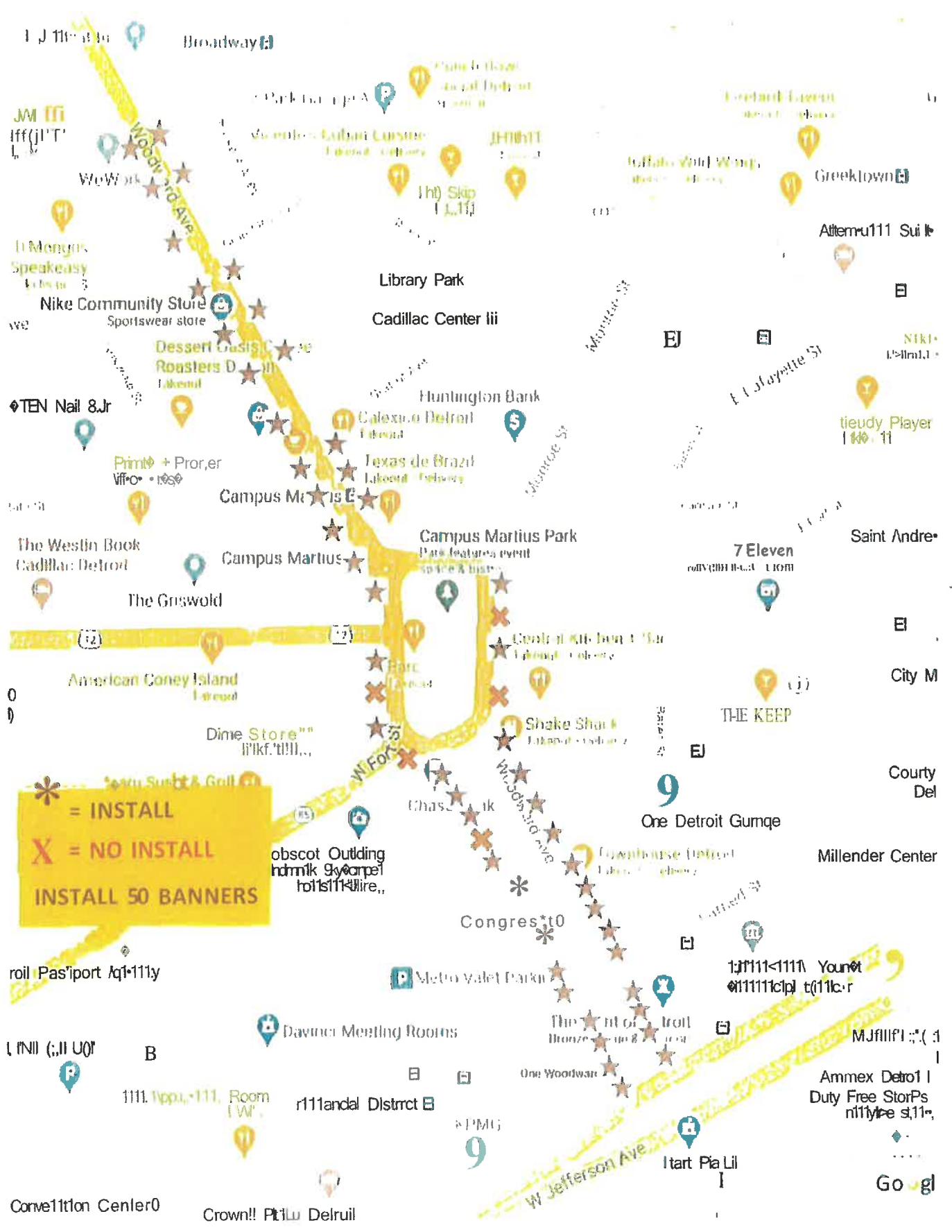
