Subject: Request to Amend the Official Compensation Schedule

The 2021 - 2022 Official Compensation Schedule be amended to include the attached pay range adjustments.

Request:

The above recommendation is at the request of the Law Department.

Rationale:

The Law Department has had issues attracting and retaining qualified attorneys and support staff. In fact, the problem has grown considerably worse over the past year with candidates for support staff openings routinely failing to appear for interviews. In addition, the Law Department has received feedback from employees that they are receiving offers externally at significantly higher salaries. The aforementioned, coupled with a major increase in the volume and complexity of work in the Law Department, necessitates adjusted pay ranges.

As a result of the issues noted above, Human Resources Classification and Compensation was asked to conduct a market study for the attorney and support staff classifications. The study was conducted using data from several external sources. The results indicate the existing pay ranges are not competitive.

It was also discovered during the study that entry and senior levels exist in the attorney series, but not an intermediate level. As a result, an intermediate level of attorney (*Associate Assistant Corporate Counsel*) was created to provide career progression opportunities for employees.

The proposed pay ranges are based on the City of Detroit's ability to fund the increases and are subject to City Council approval.
