

Commander Brian M. Mounsey 26 YEARS OF DEDICATED SERVICE DETROIT POLICE DEPARTMENT

WHEREAS On Friday, January 28, 2022, after over 26 years of dedicated service, Commander Brian M. Mounsey retired from the Detroit Police Department; **and**

WHEREAS Commander Brian M. Mounsey was appointed to the Department on June 12, 1995. After successful completion of the Police Academy, he was assigned to the Tenth Precinct as a Police Officer on November 17, 1995. On December 26, 1996, when he was reassigned to the Tactical Services Section and worked there until September 8, 1999; **and**

WHEREAS On August 23, 1999, Police Officer Brian M. Mounsey was promoted to Investigator. On September 8, 1999, he was assigned to the First Precinct Investigative Operations Unit until October 13, 2000; **and**

WHEREAS Investigator Brian M. Mounsey was promoted to Sergeant on October 27, 2000. On November 17, 2000, he was assigned to the Fourth Precinct. On September 26, 2003, he was reassigned to Narcotics Enforcement and worked there until June 15, 2006; **and**

WHEREAS Sergeant Brian M. Mounsey was promoted to Lieutenant on June 14, 2006. On June 15, 2006, he was assigned to Narcotics. On October 13, 2009, he was reassigned to the Eighth Precinct and worked there until September 12, 2014; **and**

WHEREAS Lieutenant Brian M. Mounsey was promoted to Captain on September 12, 2014 and was assigned to Night Command. On November 17, 2014, he was reassigned to Professional Standards, where he worked until January 18, 2016. He was then reassigned to the Organized Crime until April 11, 2016; **and**

WHEREAS On April 11, 2016, Captain Brian M. Mounsey was promoted to Commander and was assigned to the Second Precinct, in which he retired from his last assignment; **and**

WHEREAS During his career with the Detroit Police Department, Commander Brian M. Mounsey was the recipient of numerous awards, which included 2014 Ford Fireworks, All Star Game, Chief's Unit Award, Departmental Citation, Conclusion of Consent, Confinement Judgement, Rosa Parks Funeral, Super Bowl, and other certificates of appreciation. Additionally, he is a Graduate of Eastern Michigan University's School of Staff and Command (October 7, 2005) and the United States Department of Justice's Federal Bureau of Investigation National Academy (December 14, 2012). He has dedicated himself to the profession of Law Enforcement performing all duties to a high standard, setting as example for all to follow. NOW THEREFORE, LET IT BE
