The Michigan Department of State and the Bureau of Elections have awarded the City of Detroit Clerks Office with the FY 2025 Early Voting Grant. This federal funding is for the explicit purpose of the implementation and execution of early voting. The total amount being received for the November 2025 Election is \$83,952.75. There is no match requirement. The total allowable project cost to be reimbursed is \$83,952.75.

The objective of the grant is to aid local jurisdictions with the implementation of early voting. The funding allotted to the department will be utilized to pay for early voting wage reimbursements for only the November 2025 Election. This is a reimbursement program.
