The Law Department is hereby requesting authorization from Detroit City Council to submit a grant application to the Michigan Indigent Defense Commission for the FY 2023 Michigan Indigent Defense Commission Grant. The amount being sought is \$2,471,822.49. The State share is \$2,471,822.49 of the requested amount and there is a required cash match of \$1,095,180.33. The total project cost is \$3,567,002.82.

The FY 2023 Michigan Indigent Defense Commission Grant will enable the department to:

- Provide Counsel at first appearance for all non-represented defendants in the 36th District Court.
- Provide appointed counsel to all defendants who cannot afford an attorney.
- Ensure compliance with the Michigan Indigent Defense Commission standards to provision of counsel to indigent defendants in accordance with the Michigan Indigent Defense Commission Act.

If the application is approved, a cash match will be provided from appropriation 29600.
