Submitting reso. autho. sale by the Detroit Land Bank Authority of Fourteen (14) Properties

* SUMMARY:

The Detroit Land Bank Authority ("DLBA") has received an offer from the Michigan Department of Transportation (the "Purchaser"), to enter in to an option to purchase Fourteen (14) DLBA-owned properties located at 413, 419, 427, 433, 443, 447, 457, 515, and 521 Hendrie; 5458 & 5459 15th St.; 5955 Bewick; 6070 & 6081 Hurlbut (the "Properties"), further described in Exhibit A of the Sale Resolution, for the purchase price of One Million Five Hundred Thirty Four Thousand Eight Hundred Thirty and 00/100 Dollars (\$1,534,830.00). Pursuant to the First Amended and Restated Memorandum of Understanding ("MOU") between the City of Detroit and the DLBA, approved by the Detroit City Council on May 5, 2015, the DLBA may not transfer ten (10) or more parcels of property received from the City of Detroit to the same transferee within any rolling twelve (12) month period without the prior approval of the Mayor and City Council. The Planning & Development Department ("P&DD") requests that your Honorable Body authorize the Detroit Land Bank Authority to enter into an Option Agreement with the Michigan Department of Transportation to sell the Properties as more particularly referenced in Exhibit A.

Forward to PED Standing Committee for Recommendation with P&DD requesting the sale be forwarded back to the Council-of-the-Whole with a Recommendation for Approval.
