RE: Authorization to submit a grant application to the Federal Railroad Administration for the FY 2022 Railroad Crossing Elimination Program Grant

The Department of Public Works is hereby requesting authorization from Detroit City Council to submit a grant application to the Federal Railroad Administration for the FY 2022 Railroad Crossing Elimination Program Grant. The amount being sought is \$800,000.00. The Federal share is 80 percent or \$800,000.00 of the requested amount and there is a required cash match of 20 percent or \$200,000.00. The total project cost is \$1,000,000.00.

The FY 2022 Railroad Crossing Elimination Program Grant will enable the department to:

- Reduce railroad crossing accidents and fatalities
- Conduct a planning study to design a safer vehicle crossing for two railroad crossing locations – (1) West Chicago Blvd. between Fitzpatrick St. and the Southfield Freeway and (2) Outer Drive East between Sherwood St. and Filer St.
- Complete the Engineering Design of the two identified railroad crossings

If the application is approved, a cash match will be provided from appropriation 04189.



Brief Statement of Priorities/Purpose for the Application <i>Sample: To support expansion of promising youth development programs in MNO neighborhood.</i>	The City is planning to study and design a vehicle crossing either above or below the railroad at the two identified locations: USDOT 234224V and 511092B, both locations, separating road traffic from rail traffic and eliminating both crossings. Alternatives will be reviewed which may result in a rail bridge with the vehicle underpass at Outer Drive East (DOT 511092B) site. The proposed grade separations will provide residents, businesses, and first responders with reliable vehicular access and improve the safety, equity (connecting neighborhoods), and mobility of people and goods in Detroit.
