RE: Request to Accept and Appropriate the FY 2022 Section 5307 Congestion Mitigation Air Quality (CMAQ) - Bus Replacement Grant

The Federal Transit Administration has awarded the City of Detroit Department of Transportation (DDOT) with the FY 2022 Section 5307 Congestion Mitigation Air Quality (CMAQ) - Bus Replacement Grant, in the amount of \$5,092,000.00. There is a required State match for the award, from the Michigan Department of Transportation, in the amount of \$1,273,000.00. The total Federal and State award amount is \$6,365,000.00. There is no local match requirement. The total project cost is \$6,365,000.00.

The objective of the grant is to improve DDOT's bus fleet, enhance access and mobility within DDOT's service area, and improve air quality by providing new energy efficient buses. The funding allotted to the department will be utilized to purchase up to thirteen (13) 40-foot buses to replace existing buses that have met or exceeded their minimum useful life with newer, less polluting buses. This is a reimbursement grant.

If approval is granted to accept and appropriate this funding, the appropriation number is 21209.

Award Executive Summary: This grant provides \$5,092,000 of Federal FY 2022 Section 5307 CMAQ Flex funds, including \$1,273,000 in State funds (\$6,365,000 combined) to replace up to thirteen (13) 40-foot buses that have met or surpassed their useful life with newer, less polluting buses to be used on DDOT's fixed route service.

Purpose: DDOT will purchase buses to maintain overall transportation needs by replacing up to thirteen (13) 40-foot buses that have exceeded their useful life. New buses will provide more efficient access to destinations throughout DDOT's service area, while reducing emissions.

Activities to be performed: DDOT to purchase up to thirteen 40-foot buses to replace buses that have met or exceeded their minimum useful life with newer, less polluting buses.

Expected Outcomes: DDOT expects to have a newer more efficient bus fleet as a result of the bus replacement project.

Intended Beneficiaries: Newer buses will improve DDOT's bus fleet bringing to a state of good repair and enhance access and mobility within DDOT's service area.

Subrecipient Activities: This project does not include subrecipients.
