RE: Questions Regarding the Parcel and Property Sell to the Hantz Group

Since 2012, The Hantz Group acquired approximately 2,000 properties from the Detroit Land Bank Authority (DLBA) and the City of Detroit on the City's east side. Additionally, according to a recent Bridge Detroit article, the Hantz Group has been assessed roughly 200 blight tickets from the City, totaling \$33,110 in fines.<sup>1</sup>

- 3. Regarding the purchase agreement between the DLBA and the Hantz Group, what "claw back" provisions were established, if any?
- 4. How many extensions were given on each specific parcel and property owned by the Hantz Group or its subsidiaries since the transfer?
- 5. How many properties have since been brought up to code within compliance of the six (6) month extension?
- 6. How many properties have since been brought up to code in total, since the Hantz Group was given the six (6) month extension?
- 7. Lastly, were there any parcels and properties that were transferred from the DLBA to the City of Detroit to then be sold sell to the Hantz Group?
- 8. Is there a record of the number of parcels that were previously purchased by the Hantz Group and sold to other entities? If so, who do the other entities entail?
