#### Historical

#### FY 2023-2024 Budget Analysis by the Legislative Policy Division

The Detroit Historical Society (the "Society") is an independent, Michigan non-profit Corporation whose purpose is to educate and inspire its community and visitors by preserving and portraying the region's shared history through dynamic exhibits and experiences. Under an agreement with the City of Detroit (the "City"), the Society manages the daily operations of the Detroit Historical Museum, its gift shop, the Dossin Great Lakes Museum, and the Collections Resource Center.<sup>1</sup>

The Mayor is recommending a \$500,000 subsidy for the Detroit Historical Museum for FY 2024, in appropriation **26350 - Cultural Institutions Support**, in cost center **350093 - Detroit Historical Museum**, located in the Non-Departmental budget (**Pg. B35 - 9**). This subsidy of \$500,000, is a \$500,000 (50%) decrease from the current FY 2023 subsidy of \$1,000,000 for the museum.

The Non-Departmental budget provides funds for activities, which are not the responsibility of any other single agency. Non-Departmental is also the depository agency for General Fund subsidy appropriations, enterprise activities and for a wide variety of General Fund revenues that cannot be credited to any specific department.

#### **Questions:**

- 1. In the Four-Year Financial Plan<sup>2</sup>, for FY 2023-2024 (FY 2024), the Mayor is recommending a \$500,000 subsidy for the Detroit Historical Museum for FY 2024, a \$500,000 (50%) decrease from the current FY 2023 subsidy of \$1,000,000. What is the rationale for this decrease?
- 2. What is the projected impact of the decreased subsidy to the Detroit Historical Museum on its daily operations and exhibits?
- 3. What major initiatives/capital expenses does the Detroit Historical Museum have planned for the upcoming FY 2024?
- 4. Please provide the museum's FY 2023 operating budget, and the FY 2024 operating budget, if available.
- 5. Please provide the budgeted level of positions for FY 2023, the actual level of positions as of February 28, 2023, and the level of vacancies.
- 6. Are there any plans for the Detroit Historical Museum to modify its staff or visiting hours in the upcoming FY 2024?
