Dear Chief Tim Slusser,

I'm reaching out on behalf of MoGo to express our excitement and support for the City of Detroit's proposal to the SEMCOG Carbon Reduction Program as an Act-51- eligible entity. We also wanted to share our match commitment to the MoGo Electric Expansion Project. MoGo believes that increasing access to bikeshare is a powerful way to reduce carbon emissions from the transportation sector. The bicycles purchased with these grants funds will be all electric, which studies have consistently shown being able to better replace car trips of less than 5 miles. Many of the stations purchased will not only be electrified and able to charge the e-bikes, but will be solar powered by panels rigorously tested for use with bike share in all seasons.

If awarded, MoGo is committing \$169,168 in match from our general funds, which will be used to cover the 20% local match requirement of the course of the grant.
