We have reviewed the above-captioned lawsuit, the facts and particulars of which are set forth in a confidential memorandum that is being separately hand-delivered to each member of Your Honorable Body. From this review, it is our considered opinion that a settlement whereby the Detroit Police Department - 6<sup>th</sup> Precinct returns **Twenty Thousand**, **Seven Hundred and Four Dollars and** NO/Cents (\$20,704.00) and other personal property seized during a 10/27/20 arrest of Plaintiff is in the best interest of the City of Detroit.
