The number of carjacking incidents that have occurred at gas stations in the city of Detroit for the years 2020 through 2023.

The number of carjacking incidents that have occurred at Liquor Stores in the city of Detroit for the years 2020 through 2023. According to DPD, this data was derived from Records Management System (RMS) and this data is not available prior to 2021, when the carjacking offense code was added to RMS.

The number of carjacking incidents where a weapon was involved for the years of 2020 through 2023, according to DPD, it should be noted that the type of weapon was not described.
