**HONORABLE CITY COUNCIL**

RE: Rite Way Rehab Inc., et al. (Eben Ford) v. City of Detroit

We have reviewed the above-captioned lawsuit, the facts and particulars of which are set forth in a confidential memorandum that is being separately hand-delivered to each member of Your Honorable Body. From this review, it is our considered opinion that a settlement in the amount of **EIGHTEEN THOUSAND SEVEN HUNDRED DOLLARS AND NO/CENTS (\$18,700.00)** is in the best interest of the City of Detroit.

We, therefore, request authorization to settle this matter in the amount of **EIGHTEEN THOUSAND SEVEN HUNDRED DOLLARS AND NO/CENTS (\$18,700.00)** and that Your Honorable Body direct the Finance Director to issue drafts (1) in the amount of **TWELVE THOUSAND FIVE HUNDRED DOLLARS AND NO/CENTS (\$12,500.00)** payable to **RITE WAY REHAB, INC.** and **THEIR** attorneys, **KOUSSAN HAMOOD, PLC**; (2) **TWO THOUSAND SEVEN HUNDRED DOLLARS AND NO/CENTS (\$2,700.00)** payable to **FIRST RESPONSE TRANSPORTATION, INC.** and **THEIR** attorneys, **KOUSSAN HAMOOD, PLC**; and (3) **THREE THOUSAND FIVE HUNDRED DOLLARS AND NO/CENTS (\$3,500.00)** payable to **CHIROONE CENTERS OF MICHIGAN, PLLC**, and **THEIR** attorneys, **KOUSSAN HAMOOD, PLC**, to be delivered upon receipt of properly executed Releases and Stipulation and Order of Dismissal entered in Lawsuit No. 23-001219-NF, approved by the Law Department.
