The City of Detroit, Planning and Development Department ("P&DD") has received an offer from Ron Gonzales ("Purchaser"), to purchase certain City-owned real property at 11646 Van Dyke (the "Property"). The Property will be conveyed to Purchaser for the purchase price of Two Thousand and 00/100 Dollars (\$2,000.00).

Mr. Gonzales is the owner of the adjacent property located at 11650 Van Dyke, which he acquired in 2021. Currently, on his adjacent property are the dilapidated remains of a structure which used to house an Ice Cream parlor but has been out of use and unoccupied since 2006. **RESOLVED**, that the quit claim deed will be considered confirmed when executed by the P&DD Director, or his authorized designee, and approved by the Corporation Counsel as to form.
